Sunshine Child Care is proud to be your school's Private After School Care Provider! We look forward to providing exciting, fun activities and events for our students in our program next year and we will continue to offer Homework Helper and other academic enrichments.

Every student must have a new registration packet completed each school year even those who have been in our program this year. This is a requirement by the Broward County School Board and the Broward County Children and Family Services Licensing Department. All applications must be fully complete or will not be processed.

STUDENTS MUST BE FULLY REGISTERED AND PAID BY MONDAY, AUGUST 5th, 2011 TO GUARANTEE THEIR PLACEMENT IN OUR AFTER SCHOOL CARE PROGRAM ON THE FIRST DAY OF SCHOOL, AUGUST 22nd, 2011

There is a non-refundable \$30 yearly family registration fee. Our pay periods are set up on 18 actual school days per pay period which include Early Release Days. Our student fee is based on the Broward County School Board approved contract, which is \$2.40 per hour. Each pay period is \$175.50 for the first child and we offer a 5% discount for siblings. Payment for schools with later dismissal times are adjusted to their individual after school hours. We encourage payment by check, money order or credit card, although cash will also be accepted. First payment and registration fee is due at time of registration. Students NOT registered and paid by August 5th are not guaranteed placement on the first day of school. Those students not registered by the first day of school will NOT be able to register until Wednesday, August 24th.
